- 2. Tenders / Bidders are advised to study the tender document carefully before submitting the Tender. It will be presumed that the tenderer / bidder have considered and accepted all the terms and conditions of this tender.
- 3. Conditional bids shall liable to be rejected.
- 4. The EMD/Bid Security should be submitted through Internet Payment Gateway (IPG) / Challan / Bank Guarantee. Bank Guarantee shall be drawn in favour of "Chief Executive Officer, Bhagalpur Smart City Limited". The bid will be opened as per NIT schedule, in the presence of bidders who wish to be present.
- 5. All pages of the tender documents should essentially be signed by the bidder.

ELIGIBILITY OF BIDDERS:

Minimum eligibility criteria of the Bidders are as under: -

- (i) Bidders shall preferably be of Bihar based.
- (ii) Bidders should have authorization from Original Equipment Manufacturers Dealership Certificate. Please enclose valid manufacturers authorization letter along with bid documents, which must be valid as on the last date of the bid submission.
- (iii) The details of specifications of equipment's should be filled in **Annexure-II** and submitted with bid documents.
- (iii) Bidders should not have been blacklisted by Departments / Ministries of the Govt. of India / Govt. of Bihar or PSUs during last 3 years and continues to be so. A Declaration has to be submitted in the specified format as provided in Tender Document in **Annexure 'III'**.
- (iv) The brand / make of equipment's being supplied shall have service support i.e. Service Centre / Franchise / OEM service Centre in Bihar. The bidder must give the relevant details along with the bid.

TENDER DOCUMENTS:

Bidders are requested to go through the terms and conditions contained in the bid documents. All pages of tender document along with Terms and Conditions should be signed and submitted by the bidder, failing which the tender will be rejected.

PROCEDURE TO SUBMISSION OF THE BIDS:

- 1. The bids shall be submitted through online only (http://www.eproc2.bihar.gov.in) as per the schedule time limits. Hard copy of bid documents in not to be consider.
- 2. The bid shall be typed or printed in English only. All pages of the bid document shall be numbered consecutively and shall be signed by the bidder as proof of having read the contents therein and in acceptance thereof.
- 3. Incomplete and conditional tender will be rejected.
- 4. Copy of authorization from manufacturer for supply, installation and warranty support in case the firm is not an Original Equipment Manufacturer (OEM) of the item should be submitted.
- 5. Price quoted shall be final and inclusive of all taxes, which includes free delivery of goods at the office of Bhagalpur Smart City Limited. No extra fees, cesses etc. Will be paid by this office.
- 6. The copy of following documents should be submitted with the Bids online:
 - i. The complete Bid Document signed and sealed on each page by authorised signatory of the bidder firm / agency.
 - ii. Self attested copy of PAN card.
 - iii. Self attested copy of GST Registration.
 - iv. Self attested copy of authorized distributer certificate from the manufacturer company.
 - v. The EMD / Bid Security Rs. 19,050.00 should be submitted through Internet Payment Gateway (IPG) / Challan / Bank Guarantee. Bank Guarantee shall be drawn in favour of "Chief Executive Officer, Bhagalpur Smart City Limited".
 - vi. The Tender Documents / Bid Documents (Non-Refundable) Fee Rs. 500.00 should be submitted through Internet Payment Gateway (IPG) / Challan only as per portal http://www.eproc2.bihar.gov.in.
 - vii. Tender Processing Fee (Non-Refundable) should be submitted through Internet Payment Gateway (IPG) / Challan only as per portal http://www.eproc2.bihar.gov.in.
 - viii. Bid descriptions (Details of the authorized dealer/Agency) form (Annexure-I).

- ix. Undertaking on the letter Head of the firm duly signed and stamped (Annexure-III).

BID EVALUATION:

The Bids received from the bidders will be evaluated by BSCL. In evaluation first eligibility of the bidders will be examined and qualified bidders will be considered for evaluation of price bid. In price bid evaluation, bidder who have quoted lowest rate in individually item wise (L1) will be the successful bidder.

AWARD OF WORK:

BSCL will place purchase order for supply of items to successful bidder. Successful bidder has to supply the items within 10 days from issuing of purchase order. EMD of successful bidder will be converted into Security Deposit and EMD/SD of all other bidders will be refunded after issue of purchase order.

DELAY IN SUPPLY:

The Bidder has to deliver the necessary hardware and services in accordance with the time schedule specified in award of work. However, if there is a delay in supply within the above mentioned timeline, a penalty of 0.5% of the Cost of the Purchase Order will be imposed to the bidder on weekly basis. The maximum penalty that can be imposed is 5% of the total cost of Purchase Order.

PAYMENT TERMS:

BSCL will make payment to the selected bidder on delivery of the items & submission of bill/invoice of the material to BSCL. Security Deposit will be refunded after complete delivery of all items.
